Government: Federal, District of Columbia

District of Columbia, Office of the Chief Financial Officer

The OCFO is currently in the process of implementing a replacement for their current tax system (ITS) with MITS, the Modernized Integrated Tax System. MITS will enter production in four phases. OCFO's Enterprise Data Warehouse is required to interface with the new application for sourcing individual tax returns' related information. Delviom teamed with the prime contractor to provide implementation and integration support for the Enterprise Data Warehouse architecture.

U.S. Department of Agriculture, NRCS, Chief Financial Officer

Delviom has been working as a part of the Security Engineering and Architecture (SEA) team by providing application security leadership to the agency level by assisting the USDA NRCS CIO's organization to implement their security and privacy program. Delviom also helped build, setup and deploy the Enterprise Scan Server. Delviom also led the setup of a security test lab to build an Application Security Center of Excellence. Delvoim provided help in improving the vulnerability assessment process for the NRCS agency applications for SDLC and Continuous Monitoring, per OMB and FISMA standards.

Delviom was also tasked to provide Portfolio/Program/Project Management support to USDA NRCS OCIO specifically in the areas of Schedule Management, Earned Value Management, and Risk Management. This contract provided Program Management Office support for IT investments, project and portfolio management. Delviom also developed and provided enterprise governance and services. Delviom provides PMO support to the IT Governance Team at NRCS OCIO.
